Agreement for Indemnification, Waiver and Release of Claims and Assumption of Risk

I understand that my attendance in any program at The Canine Connection of Vermont, LLP. I acknowledge that, despite my or my dog's participation in a program(s), my dog's behavior will still not be totally predictable and he or she may, with or without warning, inflict injury or damage on persons or property. I hereby agree and acknowledge that no oral promise or statements contrary to or inconsistent with the preceding representations have been made to me or on behalf of The Canine Connection of Vermont.

In consideration of and as an inducement to the acceptance by The Canine Connection of Vermont, of my application or enrollment in any program, I hereby waive and release The Canine Connection of Vermont, its employees, officers, directors, owners, representatives, and agents from any and all liability of any nature, for injury or damage which I, my dog, any other person, any other dog, or any property may suffer, including, without limitation, any injury or damage resulting from the conduct or actions of my or any dog, and I expressly assume the risk of such damage or injury while attending any program, training session, or other function of The Canine Connection of Vermont, while on the premises of The Canine Connection of Vermont or at any The Canine Connection of Vermont event or otherwise.
